

### **BELLEVILLE WIX ACADEMY: ADMISSIONS POLICY 2020-21**

#### **Admission Number**

The agreed admission number for Belleville Wix Academy for reception year admissions in September 2020 is 44.

This consists of 30 places in the English stream reception class, and 14 places in the English/French bilingual stream reception class.

## Allocation of places: order of priority

Places will first be allocated to children with a Statement of Special Educational Needs or Education Health and Care Plan which names the school. These children will be included in the overall admission number of the school. If fewer applications than the published admission number are received, the school will offer places to all those who have applied. In the event of oversubscription, the school will offer places in the following order of priority:

- (i) Looked after children and those who ceased to be looked after children looked after because they were adopted, or because they became subject to a residence order, child arrangements order or a special guardianship order (see note 1);
- (ii) Children with a professionally supported exceptional medical need or exceptional social need for a place at a particular school, as decided by the trust (see note 2);
- (iii) Children with a sibling on the roll of the school on the date of admission living up to a distance of 800 metres from the school. Children with a sibling on the roll of the school on the date of admission living over 800 metres from the school will also receive priority where the family have not moved since the last sibling was offered a place OR the last sibling was admitted prior to 1st September 2016 (see note 3);
- (iv) Other children in order of straight line distance from home to school (see note 4).

If there are more applications than places within any category, applications will be considered in order of straight line distance from home to school (see note 4).

There is no automatic right of transfer from the school nursery to the school reception. Parents must complete the school application form and children will be allocated places in line with the order of priority above.



#### Notes:

- 1. A child looked after is a child in the care of a local authority or provided with accommodation by that authority in accordance with Section 22 of the Children Act 1989. An adopted child is defined by section 46 of the Adoption and Children Act 2002 or section 12 of the Adoption Act 1976. A residence order is defined by section 8 of the Children Act 1989. A child arrangement order is defined by section 8 of the Children Act 1989 as amended by section 14 of the Children and Families Act 2014. A special guardianship order is defined by section 14A of the Children Act 1989.
- 2. Applications made on exceptional medical grounds must be supported by a current letter from a specialist health professional. Applications made on exceptional social grounds must be supported by a current letter from a social worker or other care professional working with the family. The letters must give reasons why the child's condition or circumstances make it necessary for the child to attend the school applied for, and the difficulties that would be caused if the child had to attend an alternative school. If this information is not provided by the application closing date, the application will not be considered under this criterion. The school may request professional advice before a decision is reached.
- 3. A sibling is a full brother or sister, a step/half brother or sister living at the same address, a child who is living as part of the family by reason of a court order, or a child who has been placed with foster carers as a result of being looked after by a local authority.
- 4. The straight-line measurement used to prioritise applicants for admission to schools in Wandsworth commences in all cases at the location of the property determined by the National Land Planning Gazetteer and terminates at the central point of the school site as determined by Wandsworth Council's Geographical Information System. Measurements by alternative systems and/or to other points will not be taken into account in any circumstances. Where applicants have identical distance measurements, priority amongst them will be determined at random. The permanent address of the parent/guardian with whom the child is living on the closing date for applications will be used for this purpose. A parent/carer may be asked to provide evidence to verify an address. The council should be informed of any change of address as soon as it becomes effective.

Where a child lives with parents with shared custody/responsibility, the address where the child spends the majority of the week should be used by parents for the school application. If there is a genuine 50/50 shared arrangement in place, the address where the child lives is determined using a joint declaration from the parents stating the pattern of residence. In cases where an agreement cannot be reached between the parents and Child Benefit is claimed, the address that is registered for this claim will be used. Additional proof may be requested, e.g. court order or a solicitor's letter to confirm the arrangements.



#### ADDITIONAL INFORMATION

### Bilingual stream

Belleville Wix Academy shares its site with a French primary school, École de Wix, which is run by the Lycée Francais Charles de Gaulle de Londres. The two schools collaborate to offer an English/French bilingual stream. The bilingual stream reception class has 28 places, with 14 pupils registered through Belleville Wix Academy and 14 pupils registered through the Lycée.

- Parents/carers who wish their child to be considered for the bilingual class must complete a supplementary information form in addition to their primary school application, to be submitted by the same deadline. The supplementary information form is available from the <u>Wandsworth Borough Council website</u>. Those who <u>only</u> wish to be considered for the bilingual class must indicate this on the form.
- Allocation of a place under the sibling criterion will only be given where a sibling is on the roll of Belleville Wix Academy, not the École de Wix.
- If there are more applications than places for either the bilingual class or the English language class, children will be admitted to each class in the order of priority set out above. The waiting list for each class will also be maintained in this order.
- Parents/carers of children admitted to the bilingual class should be aware that the
  headteacher reserves the right to move a child from the bilingual class to the English language
  class and vice versa, where he or she considers this to be in the child's best interests, and
  subject to the class size not exceeding the admission number. The bilingual class cannot
  exceed 28 children, as per the bilingual agreement of May 2018.

## Method of Application for Reception

Admissions for our school are coordinated via the London Borough of Wandsworth. Parents/carers must apply through the Common Application Form.

If you live in another borough, you must apply through your local authority.

## **Waiting List**

Unsuccessful applicants (including any applications received after the closing date) will be included on the school's waiting list ranked in order of priority under the published oversubscription criteria, without regard to the date that the application was received. Please note a child's position on the waiting list can go down as well as up. For example, if a new application is received or if a child on the list moves nearer to the school, the waiting list may need to be revised. The offer of a place does not depend on the length of time your child's name has been on the waiting list.

# **Appeals**

Parents/carers whose child has been refused a place at the school have a legal right to appeal against this decision to an Independent Appeal Panel. Our school has appointed the Wandsworth Appeals Service, which is responsible for arranging appeal panels on our behalf. The school will publish an appeals timetable on its website showing the relevant deadlines.

Please be aware that the panel cannot decide whether a successful appellant should be
placed in the bilingual class or the English language class. Parents/carers who wish their child to
be considered for the bilingual class only should bear this in mind if they decide to appeal.



#### In Year Admissions

For in year admissions, parents/carers must apply to the school on the Wandsworth In Year Common Application Form. Applications will be considered in accordance with the above order of priority.

## Deferred Entry and Delayed Admission to Reception

The law states that children must attend school full-time from the beginning of the term after their fifth birthday. Children will normally start reception in the September following their fourth birthday. However parents/carers may defer their child's entry to later in the school year, or delay admission to reception to the following year. For more information on this, please read the admissions information on the Wandsworth Borough Council website.

If you wish to defer entry until later in the school year, you must still apply at the normal time through the normal application process. You should then contact the school in writing after you have been offered a place.

If you wish to delay admission to reception until the following year, you must still apply at the normal time through the normal application process, including a written request with your application. We would encourage you to contact the school first so that we can discuss how your child's needs could be met within their chronological age group, and the impact of being educated with children of a different age group, before you make your decision.
